PUBLIC NOTICE

Four Compete for Fixed MRI Scanner in New Hanover County

WILMINGTON, N.C. — Four applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to acquire one fixed MRI scanner in response to a need determination in the 2023 State Medical Facilities Plan for one fixed MRI scanner in New Hanover County.

Four applicants propose the following four projects:

- Delaney Radiology proposes to acquire one fixed MRI scanner to be located at its existing diagnostic center in Wilmington. The project is expected to cost \$2.7 million and would be completed in August 2024.
- Novant Health New Hanover Regional Medical Center proposes to acquire one additional fixed MRI scanner for a total of three fixed MRI scanners on the main hospital campus in Wilmington. The project is expected to cost \$6.8 million and would be completed in October 2024.
- Wilmington Health at Porters Neck-8090 Market Street proposes to acquire one fixed MRI scanner to be located at a new diagnostic center in Wilmington. The project is expected to cost \$3.1 million and would be completed in September 2024.
- EmergeOrtho-Wilmington Porters Neck proposes to acquire one fixed MRI scanner to be located at an existing medical clinic in Wilmington. The project is expected to cost \$2.2 million and would be completed in December 2024.

A public hearing for these projects will be held June 16 at 11 a.m. at Cape Fear Community College, Building U, Room 470, 411 N. Front St., in Wilmington.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on May 31.
