### **Approval Sought for a Nursing Facility in Wendell**

**RALEIGH** — Britthaven Inc., Hillco Ltd. and Granite Falls LTC LLC have filed a certificate of need application with the North Carolina Department of Health and Human Services to relocate 120 nursing facility beds to develop a new facility in Wendell — Triangle Health & Rehabilitation Center — by relocating 30 nursing facility beds from Bethany Woods Nursing and Rehabilitation in Stanly County, five nursing facility beds from Enfield Oaks Nursing and Rehabilitation Center in Halifax County, nine nursing facility beds from Harmony Hall Nursing and Rehabilitation Center in Lenoir County, 10 nursing facility beds from Maple Grove Health and Rehabilitation Center in Guilford County, 12 nursing facility beds from Pine Ridge Health and Rehabilitation Center in Davidson County, 20 nursing facility beds from University Place Nursing and Rehabilitation Center in Mecklenburg County, 20 nursing facility beds from Westwood Hills Nursing and Rehabilitation center in Wilkes County, and 14 nursing facility beds from Willow Creek Nursing and Rehabilitation Center in Wayne County.

The project is expected to cost \$34.1 million and would be completed in October 2026.

A public hearing for this project will be held June 14 at 10:30 a.m. in the Edgerton Building, room 26, on Dorothea Dix Campus, 809 Ruggles Drive, in Raleigh.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on May 31.
