### **Approval Sought for Relocation of Nursing Facility Beds in Mecklenburg County Liberty Commons of Mecklenburg Health and Rehabilitation Center**

**CHARLOTTE** — Liberty Commons of Mecklenburg LLC and Mecklenburg County Healthcare Properties LLC have filed a certificate of need application with the North Carolina Department of Health and Human Services for a change of scope to relocate eight nursing facility beds from Briar Creek Health Center to Liberty Commons of Mecklenburg Health and Rehabilitation Center for a total of 108 nursing facility beds.

The project is expected to cost \$11.6 million and would be completed in October 2028.

A public hearing for this project will be held Dec. 13 at noon in the Randolph Room of the Charlotte Mecklenburg Library – Allegra Westbrooks Regional Branch, 2412 Beatties Ford Road in Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Dec. 2.
