## **PUBLIC NOTICE**

### **Two Applicants Compete for Cardiac Catheterization Equipment in Henderson County**

**HENDERSONVILLE, N.C.** — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to acquire one unit of cardiac catheterization equipment pursuant to a need determination in the 2025 State Medical Facilities Plan for one unit of cardiac catheterization equipment in Henderson County.

The applicants propose two projects:

- Henderson County Hospital Corporation proposes to acquire one unit of cardiac catheterization equipment to be located at Margaret R. Pardee Memorial Hospital in Hendersonville. The project is expected to cost \$4.7 million and would be completed in March 2027.
- Fletcher Hospital Inc proposes to acquire one unit of cardiac catheterization equipment to be located at AdventHealth Hendersonville. The project is expected to cost \$2 million and would be completed in January 2027.

A public hearing for these projects will be held Oct. 21, 2025, at 10 a.m. in Kaplan Auditorium of the Henderson County Main Library, 301 North Washington St. in Hendersonville.

Anyone may file written comments concerning these proposals. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Oct. 1, 2025.
