Dear Mr. Abell:

The Certificate of Need Section (CON Section) received your letter of May 21, 2012 regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Certificate of Need Section. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Dear Mr. Smith:

This letter serves as written notification of an upcoming transaction between Curo Health Services, LLC (the "Buyer") and Community Home Care and Hospice ("CHCH" or "Community"), the d/b/a name<sup>1</sup> for the following licensed hospice agencies ("Agencies"): Community Hospice of the Carolinas, Inc., Carrolton Home Care, Inc., Community Home Care of Vance County, Inc., Community Home Care and Hospice, Inc., and Community Hospice, Inc. Information regarding each agency, including the license numbers and addresses, is set forth on Exhibit A attached hereto.

The Buyer will be acquiring a majority ownership interest in Community through a 100% stock transfer, currently proposed to close on or about May 31, 2012. Ultimately, CHCH will not change tax identification numbers, names, local management, policies or procedures in connection with this transaction.

Because this will be a stock transaction there will be no change in the ownership of the agencies set forth on Exhibit A. In other words, following the close of the transaction all of the same Community corporate entities will continue to exist and these same Community corporate entities will continue to be the owners of the agencies set forth on Exhibit A just as they are today. Accordingly, based on our review of the applicable North Carolina statutes and regulations, and conversations we have had with you or your agency, we believe that the transaction described above is not subject to Certificate of Need ("CON") review in North Carolina and that this letter satisfies any pre-closing notification obligations that may be required.

Although very little is changing with respect to the CHCH Agencies, we seek confirmation that the transaction is exempt from CON review.
