Dear Ms. Hackney:

In response to your letter of December 20, 2011 the above referenced proposal is exempt from certificate of need review in accordance with N.C.G.S 131E-184(a)(8). Therefore, RS Health Investors, LLC may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Adult Licensure and Certification Section of the Division of Health Service Regulation to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C.G.S. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Re: Exemption Notice for Rich Square Manor and Rich Square Villa (Adult Care Homes in Northampton County)

Dear Craig:

Our client, RS Health Investors, LLC is planning to acquire two adult care homes in Rich Square, Northampton County, known as Rich Square Manor and Rich Square Villas (hereafter collectively "the Facilities"). Rich Square Manor is located at 400 North Main Street in Rich Square and Rich Square Villa is located at 310 North Main Street in Rich Square. The "Inventory of Adult Care Home Beds" in the 2011 State Medical Facilities Plan shows Rich Square Manor as having 32 special care unit beds and Rich Square Villa as having 38 adult care home beds. See Exhibit A. The Facilities are also listed in the Proposed 2012 State Medical Facilities Plan as having the same number of special care unit beds and adult care home beds as shown in the 2011 State Medical Facilities Plan. See Exhibit B.

RS Health Investors, LLC is seeking to purchase the Facilities through a purchase and sale agreement. The purpose of this letter is to provide prior notice of this acquisition, which is exempt from certificate of need ("CON") review, to the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Certificate of Need Section (the "Agency"). RS Health Investors, LLC seeks confirmation that it is permitted to acquire the Facilities as described herein without CON Review, thus acquiring the Facilities' existing CON rights to own that existing health service facility (as defined in the CON statute).

### I. THE PROPOSAL

As of this date, Rich Healthcare, LLC, owns the properties and buildings comprising the Facilities which are existing "health service facilit[ies]," as that term is defined in N.C. Gen. Stat. § 131E-176(9b), and RV Assisted Living, LLC is the licensee of Rich Square Manor and Rich Square Villa. RS Health Investors, LLC will purchase the Facilities but the licensee will not change. The names of the Facilities will not change.

### II. EXEMPTION NOTICE

Under North Carolina law, a certificate of need ("CON") is required only prior to offering or developing a "new institutional health service." "New institutional health service" includes a variety of services and activities, including a capital expenditure exceeding \$2 million. N.C. Gen. Stat. § 131E-176(16)(b).

The North Carolina General Assembly saw fit to exempt certain types of services or proposals from CON review, pursuant to N.C. Gen. Stat. § 131E-184. One such exempt service or proposal includes the acquisition of an existing health service facility, "including equipment owned by the health service facility at the time of acquisition." N.C. Gen. Stat. § 131E-184(a)(8).

This project involves only the acquisition of existing adult care homes, which falls within the purview of the statutory definition of "health service facilit[ies]." After acquisition, RS Health Investors, LLC will continue to operate each Facility as an adult care home. Furthermore, RS Health Investors, LLC's acquisition of the Facilities does not entail the purchase of any major medical equipment or any *per se* reviewable equipment as defined in N.C. Gen. Stat. §§ 131E-176(140) and (16)(f1). Likewise, the acquisition does not include the offering of any *per se* reviewable services. N.C. Gen. Stat. § 131E-176(16)(f). Thus, given that the transaction involves only the acquisition of existing health service facilities, it is exempt from CON review.

### III. <u>CONCLUSION</u>

Based on the foregoing information, we hereby request the Agency's confirmation that the proposal described above is exempt from CON review, pursuant to N.C. Gen. Stat. § 131E-184(a)(8), and thus RS Health Investors, LLC may acquire the Facilities with all the existing CON rights without a CON.

In addition, we respectfully request that this request be considered on an <u>expedited basis</u> because the parties wish to proceed with this transaction as soon as possible, and before the end of 2011. Additionally, financing of the transaction is contingent upon this confirmation.
