Dear Mr. Patton:

In response to your letter of December 7, 2011, the above referenced proposal cannot be considered for exemption from certificate of need review in accordance with N.C.G.S 131E-184(a)(8), until a specific entity (or person) is identified as the acquiring company (person).

N.C.G.S 131E-184(a) "Except as provided in subsection (b), the Department shall exempt from certificate of need review a new institutional health service if it receives prior written notice from the entity proposing the new institutional health service, which notice includes an explanation of why the new institutional health service is required, for any of the following:

(8) To acquire an existing health service facility, including equipment owned by the health service facility at the time of acquisition."

The acquirer of a Certificate of Need must be identified and must initiate the request for exemption from certificate of need review. I left voice mail messages for you on December 21 or 22, 2011 and on February 7, 2012. However, in case you did not receive those messages, or they were not clear, I wanted to follow-up with this letter.



On behalf of my clients who propose to purchase all of the outstand membership interests of the above referred entity, I respectfully request that the North Carolina Division of Health Service Regulation (the "**Division**") determine whether the sale of the Piedmont membership interests is subject to Certificate of Need review by the Division.

It is my understanding that the legal entity being sold is The Foot Surgery Center Of North Carolina, L.L.C., which is or has done business as Piedmont Surgical Center. Its Facility ID number is 944499. My client is forming a North Carolina limited liability company to purchase the membership interests of Piedmont. Each member of the new North Carolina limited liability company being created to acquire Piedmont is a physician duly licensed to practice medicine in the State of North Carolina.

There will be no changes or additions in the nature of services provided at Piedmont. Also there will be no new capital expenditures. It will continue to operate under the terms of its existing Certificate of Need.
