Dear Ms. Hackney:

In response to your letter of November 20, 2012, the above referenced proposals are exempt from certificate of need review in accordance with N.C.G.S 131E-184(a)(8). Therefore, the entities listed in Exhibit A may proceed to acquire the above referenced health service facilities without first obtaining a certificate of need. However, you need to contact the Adult Care Section of the Division of Health Service Regulation to obtain instructions for changing ownership of the existing facility. Note that pursuant to N.C.G.S. §131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. If you have any questions concerning this matter, please feel free to contact this office.

Re: Exemption Notice Acquisition for eighteen Existing Adult Care Homes

Dear Craig:

Our clients, described in Exhibit 1 as the various "New Facility Owners," are acquiring the ownership of eighteen (18) adult care homes in various parts of the State (hereinafter "the Facilities"). In the chart attached as Exhibit 1, we have set forth: (1) the name and property location of each facility; (2) the county in which each Facility is located; (3) the name of the seller of the Facility in each instance; and (4) the name of the buyer (our client) in each transaction. The purpose of this letter is to provide notice of these impending acquisitions, all of which are exempt from certificate of need ("CON") review, to the North Carolina Department of Health and Human Services, Division of Health Service Regulation, Certificate of Need Section (the "Agency"). Our clients seek confirmation that they are permitted to acquire the Facilities without CON review.

I. THE PROPOSAL

These transactions are occurring as part of a business transaction in which the Facilities owned and operated by related entities are being sold by the Current Facility Owners to the New Facility Owners listed in Exhibit 1. The Current Facility Owners of the eighteen Facilities plan to convey the ownership interests in these Facilities to the New Facility Owners on or about December 21, 2012. All of these Facilities are currently operating as existing adult care home facilities.

II. EXEMPTION NOTICE

Under North Carolina law, a CON is required only prior to offering or developing a "new institutional health service." "New institutional health service" includes a variety of services and activities, including a capital expenditure exceeding \$2 million. N.C. Gen. Stat. § 131E-176(16) (b).

The North Carolina General Assembly saw fit to exempt certain types of services or proposals from CON review, pursuant to N.C. Gen. Stat. § 131E-184. One such exempt service or proposal includes the acquisition of an existing health service facility, "including equipment owned by the health service facility at the time of acquisition." N.C. Gen. Stat. § 131E-184(a) (8).

This transaction involves only the acquisition of existing adult care homes, which falls within the purview of the statutory definition of "health service facility." After acquisition, the Facilities will continue to operate as adult care homes. Furthermore, New Facility Owners' acquisition of the Facilities will not entail the purchase of any major medical equipment or any per se reviewable equipment, as defined in N.C. Gen. Stat. §§ 131E-176(14)(0) and (16)(fl). Likewise, the acquisition does not include the offering of any per se reviewable services. N.C. Gen. Stat. § 131E-176(16)(f). Thus, given that the transaction involves only the acquisition of existing health service facilities, it is exempt from CON review.

III. <u>CONCLUSION</u>

Based on the foregoing information, we hereby request the Agency's confirmation that the proposed acquisitions described above are exempt from CON review, pursuant to N.C. Gen. Stat. § 131E-184(a)(8). If you require additional information to consider this request, please contact us at the above number as soon as possible.
