In accordance with N.C General Statute 131E-184(a)(8), Fresenius Vascular Care Raleigh MSO, LLC., is writing to advise you of our intention to acquire the existing Diagnostic Center and assets of Raleigh Access Center. Please accept this letter as our formal notice of intent to acquire the facility and equipment currently owned by the facility.

Fresenius Vascular Care Raleigh MSO, LLC is registered with the North Carolina Secretary of State. A copy of the registration is included as an attachment to this letter. Fresenius Vascular Care Raleigh MSO, LLC is a joint venture between Fresenius Vascular Care, LLC, a 70% owner (FVC, LLC is a wholly owned subsidiary of Fresenius Medical Care Holdings, Inc) and Raleigh Access Center, LLC (owned by Capital Nephrology, P.A. and Wake Nephrology Associates, P.A.) a 30% owner.
