In response to your letters of June 24, 2013 and July 8, 2013, the above referenced proposal is exempt from certificate of need review in accordance with N.C.G.S 131E-184(a)(8). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.


However, you need to contact the Mental Health Licensure and Certification Section of the Division of Health Service Regulation to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Certificate of Need Section. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

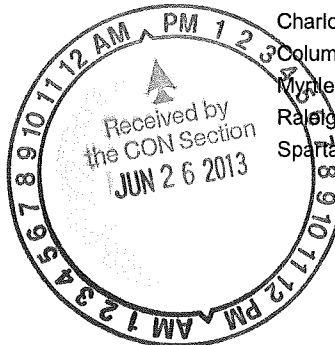

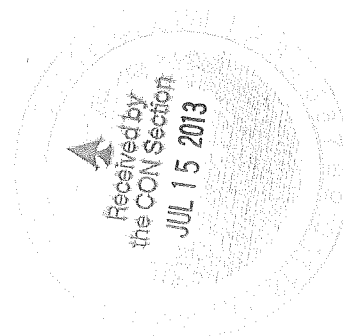

Dear Mr. Smith,

The Carter Clinic, PA is requesting a change of ownership of the Certificate of Need for the following ICF/MR facilities of Peterkin and Associates, currently owner by Alice Smith:

1. Kinlaw Road Group Home d/b/a Thomas S. Kinlaw
235 Kinlaw Road, Fayetteville, NC
Con License # MHL_026-071
2. Kilmory Drive d/b/a Extra Special Care
6214 Kilmory Drive, Fayetteville, NC
Con License # MHL_026-049

As you are likely aware, Alice Smith owned a total of 6 ICF/MR licensed homes located in Cumberland and Moore Counties. She suffered bankruptcy and had to have her property, including the Certificate of Need (CON) for these homes auctioned by a Bankruptcy Trustee. The first four home were auctioned in February of this year and the sale was certified by the Bankruptcy Judge in March of 2013. The last two homes to be sole were the Kinlaw Road Group Home (Thomas S. Kinlaw) and the Kilmory Drive (Extra Special Care) and this occurred on June 19th 2013 in bankruptcy court to my company the Carter Clinic,

PA. We are now attempting to complete the CON transfer and request to be "Exempt from Review".

Carter Clinic, PA has offices located in Fayetteville North Carolina and is prepared to assume full responsibility for the operations of these two facilities to include staff and key personnel.


