Dear Ms. Harris:

In response to your letter of June 26, 2013, the above referenced proposal is exempt from certificate of need review in accordance with G.S 131E-184(a)(8). Therefore, The Moses H. Cone Memorial Hospital Operating Corporation d/b/a Cone Health may proceed to acquire the above referenced health service facility without first obtaining a certificate of need. However, you need to contact the Acute and Home Care Licensure and Certification Section of the Division of Health Service Regulation to obtain instructions for changing ownership of the existing facility. Note that pursuant to G.S. 131E-181(b): "A recipient of a certificate of need, or any person who may subsequently acquire, in any manner whatsoever permitted by law, the service for which that certificate of need was issued, is required to materially comply with the representations made in its application for that certificate of need."

It should be noted that this Agency's position is based solely on the facts represented by you and that any change in facts as represented would require further consideration by this Agency and a separate determination. Acquisition of Greensboro Imaging at Kernersville

Dear Mr. Smith and Ms. Inman:

This letter constitutes prior written notice that The Moses H. Cone Memorial Hospital Operating Corporation (d/b/a Cone Health) will be acquiring an existing diagnostic center operated by Diagnostic Radiology Imaging, LLC ("DRI, LLC") in Kernersville and all equipment associated with the diagnostic center. This transaction is exempt from Certificate of Need ("CON") review pursuant to N.C. Gen. Stat. § 131E-184(a)(8).

On September 6, 2007, DRI, LLC (lessee) and The Moses H. Cone Memorial Hospital and The Moses H. Cone Memorial Hospital Operating Corporation (lessor) received the attached CON authorizing them to develop a diagnostic center at 1635 North Carolina 66, Kernersville, Forsyth County, NC 27284. The facility is operated under the name of Greensboro Imaging at Kernersville and has been in continuous operation since June 2008. After Cone Health acquires the diagnostic center, it will operate the diagnostic center as an Independent Diagnostic Testing Facility ("IDTF").

The acquisition of "an existing health service facility, including equipment owned by the health service facility at the time of acquisition" is exempt from CON review. N.C. Gen. Stat. § 131E-184(a)(8). As you know, "health service facility" is defined to include a diagnostic center. N.C. Gen. Stat. § 131E-176(9b).

Based on the foregoing information, we hereby request the CON Section's confirmation that the transaction described herein is exempt from CON review under N.C. Gen. Stat. § 131E-

- 3. Diagnostic Radiology & Imaging, LLC (lessee) and The Moses H. Cone Memorial Hospital and The Moses H. Cone Memorial Hospital Operating Corporation collectively d/b/a Moses Cone Health System (lessor) shall not acquire, as part of this project, any equipment that is not included in the project's proposed capital expenditure in Section VIII of the application or that would otherwise require a certificate of need.
