Dear Mr. Mason:

The Certificate of Need Section (CON Section) received your letter of March 5, 2013 regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

Moreover, you need to contact the Acute and Home Care Licensure and Certification Section of the Division of Health Service Regulation (DHSR) to determine if they have any requirements for your change of address.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Certificate of Need Section. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the



Dear Mr. Smith,

A CON was issued to Continuum II Home Care & Hospice, Inc. ("Continuum") to establish a hospice home care agency on July 11, 2006. Continuum subsequently implemented this project and continues to operate the agency known as Continuum Home Care & Hospice of Halifax County.

Pursuant to N.C. Gen. Stat. § 131E-184(a), I am writing to advise the CON Section that Continuum intends to relocate its Halifax County agency offices from 544 Julian R. Allsbrook Hwy., Roanoke Rapids, NC 27870 (the "Present Location"), to 1609 E. 10th St. Unit 3, Roanoke Rapids, NC 27870 (the "New Location") effective April 3, 2013. The New Location is approximately one (1) mile and three (3) minutes from the Present Location. See Exhibit A. Furthermore, the New Location is closer to the local hospital, more visible and accessible to the public, more spacious for community outreach and support events, and more cost-effective than the Present Location. Ultimately, we do not believe that this relocation involves any activities that would constitute a "new institutional health service" as that term is defined in N.C. Gen. Stat. § 131E-176(16).

In advance of this planned April 3, 2013 move date, I would appreciate your written confirmation that this proposed relocation does not require a CON.


