Dear Ms. Gunter:

The Certificate of Need Section (CON Section) received your letter(s) of & (date or dates) regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

Moreover, you need to contact the Construction and the Acute and Home Care Licensure and Certification Sections of the Division of Health Service Regulation to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Certificate of Need Section. Changes in a project include, but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the

original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

Dear Craig:

FirstHealth Moore Regional Hospital (Moore Regional) received a CON in 2005 that allowed it to renovate its Emergency Department (ED) and increase the number of treatment rooms from 34 to 40 rooms. See Exhibit A. Since that time, Moore Regional's ED volume has increased dramatically, as reflected in the chart below:

License Renewal Application Year	Number of ED Visits

2013	65,530

Thus, over time, Moore Regional's ED visits have grown by 11,117 visits, which is approximately a 20% increase. Volume in the ED has increased 4.2% over the past year.

Moore Regional projects that in Calendar Year 2013, its ED visits will be 70,000.

As you know, rapid ED treatment is vitally important. The ED's goals are to provide timely, quality care for all presenting people to the department just as FirstHealth's mission is *To Care for People*. Moore Regional estimates that by adding ED treatment rooms, it can significantly improve ED wait times. ED wait times are a leading cause of patients leaving without treatment (LWOT). It is FirstHealth's goal to have LWOT levels below 0.9% of Moore Regional's ED volume. Unfortunately, due to rising ED volumes and capacity constraints in the ED, FirstHealth is seeing its LWOT levels rise. Adding additional ED treatment capacity, as outlined in this letter, will improve wait times and thus reduce LWOT levels.

Moore Regional has determined that 40 treatment rooms are insufficient to meet the growing needs of the community, and that nine additional treatment rooms and one supply room are needed.

To implement nine additional treatment rooms and one supply room, Moore Regional would utilize ten rooms in its FirstAdmit area. The FirstAdmit area is an observation area where Moore Regional holds patients awaiting admission until a bed is free. The FirstAdmit area is actually within the ED. These FirstAdmit rooms are presently stocked and have telemetry monitoring capability like the other ED treatment rooms. No construction is needed to make nine FirstAdmit rooms into ED treatment bays. The only construction that would be needed is to convert one of the FirstAdmit rooms into a supply room. The capital cost for the supply room construction is \$11,332.44. See Exhibit B for quotes. See also Exhibit C for a line drawing.

This proposal does not implicate any of the definitions of "new institutional health service" in N.C. Gen. Stat. § 131E-176(16). This proposal does not increase FirstHealth's licensed bed capacity. Accordingly, FirstHealth respectfully requests that the CON Section determine that this proposal is in material compliance with the CON issued for Project I.D. No. H-7282-05 and otherwise does not require a CON.

The change of the current rooms from holding areas to emergency treatment rooms will allow more flexibility to see more volume in a timely manner, decrease people leaving without being seen and promote patient flow.

Please let me know if you have any questions. Due to rapidly-growing ED volumes FirstHealth respectfully requests that the CON Section respond to this request as soon as possible.



- Annular spaces must fall between UL System maximums and minimums per UL drawings.
- Price quoted is based on current insurance coverage.
- Price quoted does not include any allowance for bonding.
- Price quoted includes C.L. Downey employees cleaning up during and after their scope of work.
- Price does not include any on-site training or drug testing.
- All necessary parking permits and or passes provided by Customer.
