The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your correspondence regarding the above referenced proposal. Based on the CON law in effect on the date of this response to your request, the proposal described in that correspondence is not governed by, and therefore, does not currently require a certificate of need. If the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

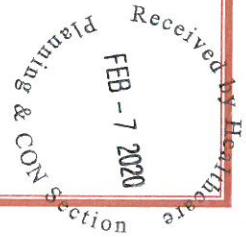

I am writing on behalf of Cabarrusco, LLC; AA Holdings-Kannapolis, LLC; and Cabarrus AL Holdings, LLC (together, the “Co-Applicants”), North Carolina limited liability companies with their principal places of business located at 400 Second Avenue NW, Hickory, North Carolina 28601. The Co-Applicants are currently completing development of Project ID #F-10311-14 (the “Project”), which involves the construction of *Cabarrus Manor* in Cabarrus County, North Carolina (the “Facility”). The Project’s Certificate of Need was issued to the Co-Applicants on May 15, 2015.


The Co-Applicants, in coordination with their proposed management company, Affinity Living Group, LLC (“ALG”), wish to change the name of the Facility from “*Cabarrus Manor*”, as it was referred to in the original Certificate of Need application and in the Certificate of Need granted by the Agency, to “*The Landings of Cabarrus.*” Changing the name of the Facility to *The Landings of Cabarrus* would allow this Project to conform with standardized naming conventions that have recently been instituted and are currently being implemented at ALG-managed facilities across North Carolina.

In accordance with N.C. Gen. Stat. § 131E-189(c), I intend for this letter to serve as prior written notice to the Agency of the proposed name change for the Facility. Furthermore, it is my understanding that the proposed name change should not entail any additional filings. Therefore, I respectfully request that the Agency issue a No Review finding for this matter.
