The facility was found in compliance with 42 CFR §483.80 infection control regulations and has implemented the CMS and Centers for Disease Control and Prevention (CDC) recommended practices to prepare for COVID-19. One of the one complaint allegations was substantiated resulting in deficiency.  On June 23, 2020 an amended 2567 report was issued to the facility because tag F-602 was deleted by the survey team prior to the facility's requested IDR.
