To have to visit all clients of every aide while the aide is there performing service at some point during the year creates more hardship in scheduling visits, more gas and seems redundant. Currently we do a telephone call a quarter with a visit at least once a year or more if warranted for a Level I and visit one client of each aide per quarter.				Now an In-Home Aide only does hands on care, leaving out the level 1, home management only, aides who now become sitters or companions. These aides do other things besides "sitting." This is a major setback in understanding and recruitment efforts for direct care workers.
