: 	1	(8) fails to report to the Department any arrest or conviction.
	2	(b) The Department shall suspend the certification of an administrator due to any arrest with a relationship between
	3	the alleged criminal conduct and job duties that has been determined by the Department to indicate a need to seek
	4	action in order to further protect facility residents pending adjudication by a court. Serving as an administrator while
	5	the administrator's certification is suspended shall be grounds for revocation of certification. Examples of criminal
	6	conduct the Department may consider in relation to job duties are fraud, physical assault, theft, abuse, neglect
	7	exploitation, and drug diversion.

- 4 Administrator certification shall be renewed by the Department pursuant to G.S. 90-288.15 based on the
- 5 administrator's biennial submission of course completion certificates issued by the course provider, dated from last
- 6 certification, initial or renewal, and totaling 30 hours of coursework related to long term care management or the care
- of aged and disabled persons, and a renewal fee of \$30.00 pursuant to G.S. 90-288.15A. Examples of coursework
- 8 related to long term care management or the care of aged and disabled persons are financial management, human
- 9 resource management, medication administration, dementia care, diabetic care, managing aggressive behaviors and
- 10 <u>infection control.</u>
