**MEMORANDUM**

**TO:** Interested Parties

**FROM:** Megan Lamphere, Rule-making Coordinator 

**RE:** Proposed Amendments and Repeals of Radiation Protection Rules

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a permanent rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal note that has been prepared in connection with the proposed rule.

The Radiation Protection Commission has submitted the Notice of Text to the Codifier of Rules, Office of Administrative Hearings, indicating our intent to amend the following Radiation Protection rules:

- 15A NCAC 11 .0104, .0105, .0117, .0301, .0303, .0304, .0305, .0309, .0317, .0318, .0321, .0322, .0328, .0331, .0333, .0334, .0338, .0352, .0358, .0361, .0362, .1004, .1604, .1626, .1633, and .1648

The Commission also intends to repeal the following Radiation Protection rules:

- 15A NCAC 11 .0325, .0326

These rules will be published in the North Carolina Register on May 15, 2013. A public hearing is scheduled for July 10, 2013 at 10:00 a.m. in Conference Room 101, 3825 Barrett Drive, Raleigh, NC 27609. The Commission is accepting public comments on these rules and fiscal note from May 30, 2013 – July 15, 2013. Comments may be submitted electronically to the rulemaking coordinator at [DHSR.RulesCoordinator@dhhs.nc.gov](mailto:DHSR.RulesCoordinator@dhhs.nc.gov) or in writing to the address below. Comments can also be made at the public hearing.
