Purpose of Hearing

This is the public hearing for the proposed amendment and fiscal note for Nursing Pool Licensure rules 10A NCAC 13L .0201, .0301 and .0302.

The purpose of this meeting is not to discuss or debate the rules and fiscal note but rather, to accept comments from the public on these proposed rules and fiscal note that was prepared for these rules. The Department will receive public comments through close of business on January 30, 2015. All comments, including those from this public hearing, are considered prior to the MCC adopting the proposed rules and submitting them to the Rule Review Commission for approval.

The public hearing was opened by Taylor Corpening at 11:00 a.m. No members of the public were present. The meeting was recessed at 11:01 a.m. for 20 minutes to allow for more members of the public to attend.

Medical Care Commission's granting of a petition submitted for rulemaking. NCHCFA submitted the initial petition that led to these two proposed revised rules.

Adam also reiterated NCHCFA's original petition asking for many other changes to the
