RE: CEASE OPERATION OF UNLICENSED ADULT CARE HOME

Located at: 3830 North Main Street, High Point, NC 27265 dba Forsyth Senior Estates and Forsyth Senior Estates Multi Unit Assisted Housing and Rehabilitation and Forsyth Senior Estates and Rehabilitation

County: Forsyth

Dear Ms. Henry:

Staff from the Division of Health Service Regulation Adult Care Licensure Section visited your residence at 3830 North Main Street, High Point, NC on September 17-18, 2025, and on September 23-24, 2025, and determined that you are currently operating an adult care home without a license. You are hereby ordered to cease and desist all adult care home operations at your residence, effective immediately.

All residents and their responsible parties are to be informed immediately of this order, and residents must be removed from your premises as soon as other placement arrangements can be made. Forsyth County Department of Social Services (DSS) has been notified of this order and you may contact them at (336) 703-3821 for assistance with appropriate relocation of residents. Failure to respond immediately will result in our agency filing an injunction with Forsyth County Superior Court to restrain or prevent the establishment, conduct, management or operation of an adult care home without a license.

The following facilities are not required to be registered or obtain a license from the Adult Care Licensure Section according to N.C. General Statute § 131D-2.3:

1. Facilities licensed under Chapter 122C or Chapter 131E of the General Statutes;
2. Persons subject to rules of the Division of Employment and Independence for People with Disabilities;
3. Facilities that care for no more than three persons, all of whom are under the supervision of the United States Veterans Administration;



4. Facilities that make no charges for housing, amenities, or personal care services, either directly or indirectly; and
5. Institutions that are maintained or operated by a unit of government and that were established, maintained, or operated by a unit of government and exempt from licensure by the Department on September 30, 1995.

In order to be exempt from licensure, a home providing personal care services or supervision to more than one person, must meet any one of the exemptions above in its entirety. If any of the above exemptions are not entirely met, the home is subject to licensure. N.C. General Statute § 131D-2.6(b) states that “any individual or corporation that establishes, conducts, manages, or operates a facility subject to licensure under this section without a license is guilty of a Class H felony, including a fine of one thousand dollars (\$1,000) per day for each day the facility is in operation in violation of this Article. Each day of a continuing violation after conviction shall be considered a separate offense.” If you fail to cease operation immediately, further action may be taken by our agency to cause the operations to cease.
