## **Three Applicants Compete for fixed PET Scanner in Triad Area**

**WINSTON-SALEM, N.C.** — Three applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop one fixed PET scanner in response to a need determination in the 2023 State Medical Facilities Plan in [Health Services Area II](#), which covers the Triad area of the state.

The three applicants and proposals are as follows:

- Moses H. Cone Memorial Hospital and Moses H. Cone Memorial Hospital Operating Corporation propose to develop one fixed PET scanner in Greensboro at Cone Health. The project is expected to cost \$2.2 million and would be completed in April 2025.
- Forsyth Memorial Hospital Inc. and Novant Health Inc. propose to develop a second fixed PET scanner in Winston-Salem at Novant Health Forsyth Medical Center. The project is expected to cost \$6 million and would be completed in April 2025.
- Piedmont Cardiovascular, P.A. proposes to develop one fixed PET scanner in Greensboro at Piedmont Cardiovascular, P.A. The project is expected to cost \$57,050 and would be completed in June 2024.

A public hearing for these projects will be held Nov. 16 at 11 a.m. in the auditorium of the Forsyth County Public Library-Reynolda Manor Branch, 2839 Fairlawn Drive NW in Winston-Salem.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Oct. 31.
