PUBLIC NOTICE

Two Compete for Nursing Facility Dialysis Stations in Mecklenburg County

CHARLOTTE, N.C. — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop dialysis stations in response to an adjusted need determination in the 2023 State Medical Facilities Plan for six outpatient dialysis stations at a nursing home facility.

The applicants and proposals are:

- The Charlotte-Mecklenburg Hospital Authority proposes to develop six dialysis stations at Atrium Health Huntersville Oaks in Huntersville. The project is expected to cost \$3.2 million and would be completed in June 2025.
- Liberty Commons Nursing and Rehabilitation Center of Matthews LLC proposes to develop six dialysis stations at Royal Park Rehabilitation and Health Center in Matthews. The project is expected to cost \$722,812 and would be completed in July 2025.

A public hearing for these projects will be held Nov. 17 at 11 a.m. in the Randolph Room of the Allegra Westbrooks Regional Library, 2412 Beatties Ford Road, Charlotte.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Oct. 31.
