PUBLIC NOTICE

Two Compete for Cardiac Catheterization Equipment in New Hanover County

WILMINGTON, N.C. — Two applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to acquire one unit of cardiac catheterization equipment in response to a need determination in New Hanover County in the 2023 State Medical Facilities Plan.

The two applicants and proposals are as follows:

Novant Health New Hanover Regional Medical Center and Novant Health Inc. propose to acquire one unit of cardiac catheterization equipment in Wilmington, N.C., at Novant Health Scotts Hill Medical Center. The project is expected to cost \$6.4 million and would be completed in October 2026.

Wilmington ASC LLC proposes to acquire one unit of cardiac catheterization equipment in Wilmington, N.C., at Wilmington ASC. The project is expected to cost \$6.8 million and would be completed in June 2025.

A public hearing for these projects will be held Oct. 19 at 10 a.m. at the South East Area Health Education Center in its Pelican Classroom, 2511 Delaney Ave. in Wilmington.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on Oct. 2.
