Three Applicants Compete for Medicare-Certified Home Health Agency in Cleveland County

SHELBY, N.C. — Three applicants have filed certificate of need applications with the North Carolina Department of Health and Human Services to develop a Medicare-certified home health agency in response to a need determination in the 2024 State Medical Facilities Plan.

Each applicant proposes the following:

- CaroMont Partners LLC proposes to develop one Medicare-certified home health agency in Shelby — CaroMont Partners. The project is expected to cost \$110,007 and would be completed in July 2025.
- Personal Home Care of North Carolina LLC proposes to develop one Medicare-certified home health agency in Shelby — PHC Home Health-Cleveland. The project is expected to cost \$55,000 and would be completed in January 2025.
- Well Care Home Health of Cleveland Inc. proposes to develop one Medicare-certified home health agency in Shelby — Well Care Home Health of Cleveland. The project is expected to cost \$100,000 and would be completed in July 2025.

A public hearing for these projects will be held April 17 at 11 a.m. in the Brownie Plaster Meeting Room of the Eugenia H. Young Memorial Library, 104 Howie Drive in Shelby.

Anyone may file written comments concerning this proposal. Comments must be received by the Healthcare Planning and Certificate of Need Section no later than 5 p.m. on April 1.
