The Certificate of Need Section (CON Section) received your letter of November 13, 2012 regarding the above referenced proposal. Based on the CON law **in effect on the date of this response to your request**, the proposal described in your correspondence is not governed by, and therefore, does not currently require a certificate of need. However, please note that if the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

Moreover, you need to contact the Acute and Home Care Licensure and Certification Section of the Division of Health Service Regulation to determine if they have any requirements for development of the proposed project.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to

Pursuant to N.C. Gen. Stat. § 131E-184(a), I am writing to advise that the following three hospice branch locations will be changing location.

First, Carrolton Home Care, Inc. d/b/a Community Home Care and Hospice, located at 117 Village Road, Suite E, Box 15, Leland, North Carolina 28451 (the "Current Location") is relocating this hospice branch office to 497 Olde Waterford Way, Suite 208, Belville, North Carolina 28451 (the "New Location"). The New Location is approximately 2.25 miles and 4 minutes from the Current Location. See Exhibit A. A March 16, 2005 letter from the CON Section confirming that the establishment of this branch office does not require a CON is attached as Exhibit B. This relocation does not involve any activities that would implicate the definition of "new institutional health service" as that term is defined in N.C. Gen. Stat. § 131E-176(16).

Second, Community Hospice, Inc. d/b/a Community Home Care and Hospice, located at 714 W. Corbett Ave., Suite 20, Swansboro, North Carolina 28584 (the "Current Location") is relocating this hospice branch office to 662 W. Corbett Ave., Swansboro, North Carolina 28584 (the "New Location"). The New Location is approximately 0.26 miles and 30 seconds from the Current Location. *See Exhibit C.* A February 3, 2005 letter from the CON Section confirming that the establishment of this branch office does not require a CON is attached as Exhibit D. This relocation does not involve any activities that would implicate the definition of "new institutional health service" as that term is defined in N.C. Gen. Stat. § 131E-176(16).

Third, Community Hospice, Inc. d/b/a Community Home Care and Hospice, located at 3328 D Bridges Street, Morehead City, North Carolina 28557 (the "Current Location") is relocating this hospice branch office to 710 Arendell Street, Kirkman Whitford Building, Office 203C, Morehead City, NC 28557 (the "New Location"). The New Location is approximately 2.67 miles and 7 minutes from the Current Location. *See Exhibit E.* A January 18, 2005 letter from the CON Section confirming that the establishment of this branch office does not require a CON is attached as Exhibit F. This relocation does not involve any activities that would implicate the definition of "new institutional health service" as that term is defined in N.C. Gen. Stat. § 131E-176(16).

The relocations of the Swansboro (HOS3006) and Leland (HOS3010) branch locations are scheduled to occur on January 1, 2013. The relocation of the Morehead City (HOS2998) branch location is scheduled to occur on January 15, 2003. In advance of these dates, I would appreciate your written confirmation that the proposed relocations do not require a CON.
