The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency) received your correspondence regarding the above referenced proposal. Based on the CON law **in effect on the date of this response to your request**, the proposal described in that correspondence is not governed by, and therefore, does not currently require a certificate of need. If the CON law is subsequently amended such that the above referenced proposal would require a certificate of need, this determination does not authorize you to proceed to develop the above referenced proposal when the new law becomes effective.

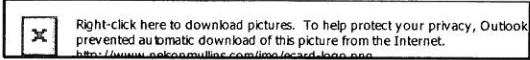

Dear Ms. Frisone:

I am writing on behalf of Murphy Post-Acute and Wellness, LLC, which operates an agency known as Good Shepherd Home Health and Hospice Agency under two (2) licenses, HC 0275 (Clay County) and HC 0318 (Cherokee County), with hospice and home health appearing on each license (the "Agency"). Murphy Post-Acute and Wellness, LLC, is affiliated with Chattanooga-Hamilton County Hospital Authority d/b/a Erlanger Health System ("Erlanger"), and Erlanger is exploring the sale of the Agency's home health and hospice operations to two different buyers. Potential Buyer 1 would acquire the home health operations (operating both the parent and branch offices post-closing), and Potential Buyer 2 would acquire the hospice operations.

In order to pursue these potential transactions, Erlanger would like to work with the Acute and Home Care Licensure & Certification Section to have the Agency's current licenses divided into three separate licenses -- two for home health (one for the parent office and the other for the branch office) and one for hospice. We would anticipate that each of the prospective buyers would provide the Certificate of Need Section with prior written notice of the exempt acquisition of the existing health service facilities pursuant to N.C. Gen. Stat. § 131E-184(a)(8).

It is our understanding that since Agency is already licensed to provide all of these services, and has been for many years, the issuance of these separate licenses by the Acute and Home Care Licensure & Certification Section would not require certificate of need review. We respectfully request that you confirm that no certificate of need review would be required prior to the Acute and Home Care Licensure & Certification Section issuing three separate licenses for these services as described above.
