The Healthcare Planning and Certificate of Need Section, Division of Health Service Regulation (Agency), determined that the above referenced project is exempt from certificate of need review in accordance with G.S. 131E-184(g). Therefore, you may proceed to offer, develop or establish the above referenced project without a certificate of need.

It should be noted that this determination is binding only for the facts represented by you. Consequently, if changes are made in the project or in the facts provided in your correspondence referenced above, a new determination as to whether a certificate of need is required would need to be made by the Agency. Changes in a project include but are not limited to: (1) increases in the capital cost; (2) acquisition of medical equipment not included in the original cost estimate; (3) modifications in the design of the project; (4) change in location; and (5) any increase in the number of square feet to be constructed.

**RE: Request for Exemption from CON Review for Emergency Department Expansion,  
Doshier Hospital, Southport, Brunswick County FID #923286**

Dear Ms. Mitchell, Ms. Pittman, and Ms. Saporito,

Please accept this as required written notification on behalf of Doshier Hospital that it intends to spend approximately \$9 million on new construction to expand the main hospital building to include a new Emergency Room. The project will be in space immediately adjacent to the existing main campus building as illustrated on the Attached site plan.

With the proposed project, Doshier Hospital main hospital building will have additional square feet. **Attachment A** illustrates the location of the Emergency Department project. The project will involve some demolition of existing medical office buildings. Staff in this space will relocate to vacant space in the former nursing home and to other office buildings owned by Doshier Hospital. When the new ED is complete in December 2025, the former Emergency Department space will be used for wound care and general surgery outpatient clinics.

The Emergency Department was last updated in 2011. Since then, both Smithfield Township and Brunswick County populations have grown exponentially. The area is a retirement center, a tourist destination, and a growing residential community. The result is that our small emergency room must expand to accommodate the more than 12,000 annual visits.

The Master Facility Plan includes several other improvements/ renovations to the existing hospital building between now and 2026:

- Upgrade Sterile Processing
- Expand Operating Room Support spaces – no increase in operating rooms
- Expand Lab waiting and support space
- Expand Pharmacy clean rooms
- Renovate existing ED space for wound and general surgery outpatient clinics

- Consolidate Multispecialty Clinic

This project satisfies the requirements under N.C.G.S. 131E-184(g) for "any capital expenditure that exceeds the four-million-dollar (\$4,000,000) threshold set forth in G.S. 131 E-176(16)b if all of the following conditions are met:

- (1) The sole purpose of the capital expenditure is to renovate, replace on the same site, or expand the entirety or a portion of an existing health service facility that is located on the main campus.
- (2) The capital expenditure does not result in (i) a change in bed capacity as defined in G.S. 131E-176(5) or (ii) the addition of a health service facility or any other new institutional health service other than that allowed in G.S. 131E-176(16) b.
- (3) The licensed health service facility proposing to incur the capital expenditure shall provide prior written notice to the Department, along with supporting documentation to demonstrate that it meets the exemption criteria of this subsection.

J. Arthur Doshier Memorial Hospital {"Doshier Hospital"} is a licensed acute care hospital, License No. H-0150. The renovation entails expansion of the main building, on the "main campus" as defined by GS 131E-176(14n). In that main hospital building Doshier Hospital provides clinical patient services and exercises financial and administrative control over the entire licensed health service facility.

Administrative offices are in the same main building, illustrated in [Attachment A](#).

- a. All services in the project are located in, or will be an extension of the main building, with one exception, the Multispecialty Clinic.
- b. The Multispecialty Clinic is within 250 yards of the main building; and even if it were not, it would qualify for a physician office building exemption under G.S. 131E-184(a)(9).


Doshier Hospital also plans to upgrade its Electronic Medical Record System. This would qualify for an Exemption under G.S. 184 (a)(3) " to provide data processing equipment."

Doshier Hospital also intends to develop two physician office buildings costing less than \$2.0 million each. These would qualify for an exemption under G.S. 131E-184(a)(9).

The estimated total capital expenditure of all elements exceeds the four-million-dollar threshold set forth in G.S. 131 E-176(16) b. [Attachment C](#) contains a summary of the proposed project costs. The capital expenditure will not result in either a change in bed capacity as defined in G.S. 131E-176(5) or the addition of a health service facility or any other new institutional health service other than that allowed in G.S. 131E-176(16) b.

We would appreciate your confirmation that this project is exempt from CON review. Thank you for your attention to this request. If you have questions, please let me know.

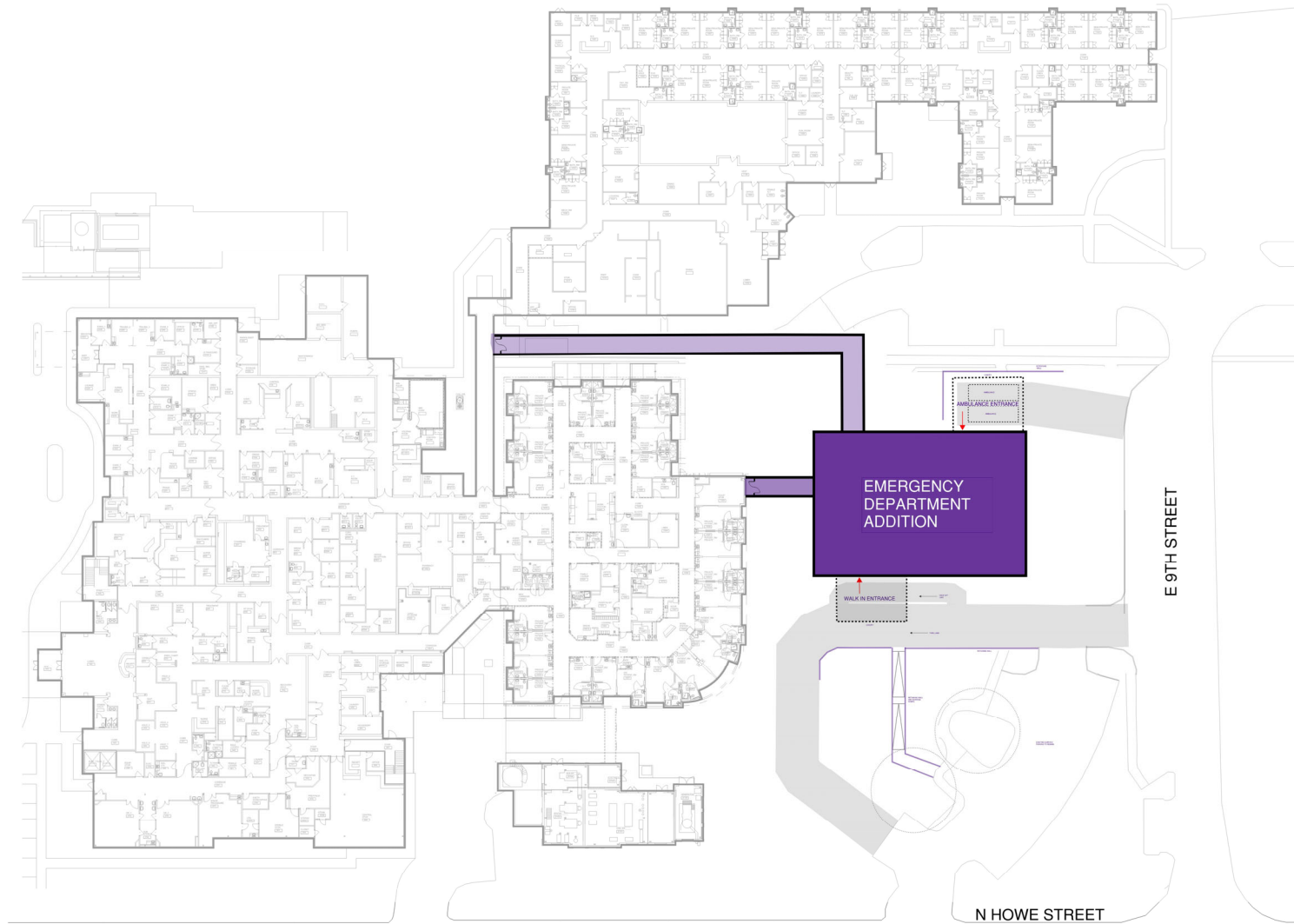

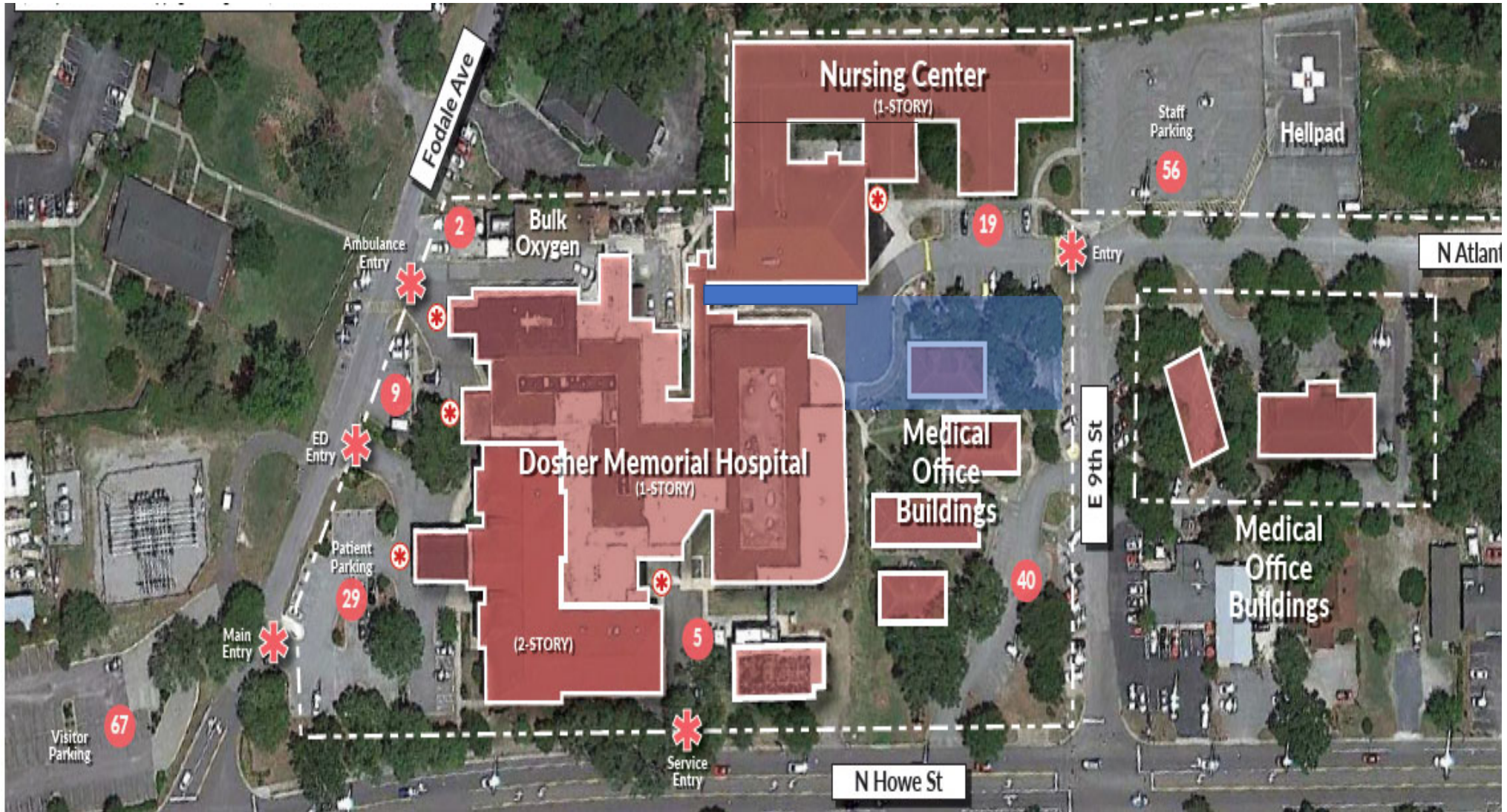
# Emergency Department Floor Plan/Site Plan
