Re: Request for No Review/ Acquire a CT Scanner at WakeMed Raleigh Medical Park/Wake County

Dear Ms. Kearney:

This letter is to inform the Healthcare Planning and Certificate of Need Section of WakeMed's intent to purchase a fixed CT scanner to be located in existing space at Raleigh Medical Park, 23 Sunnybrook Rd, Raleigh, NC 27610. Raleigh Medical Park operates under the WakeMed license (H0199) and CMS Certification Number (340069). WakeMed plans to purchase a new Siemens Somatom Pro Pulse CT Scanner, allowing for faster scanning times, improved patient throughput, reduced patient exposure to radiation, enhanced image quality and reduced maintenance costs. Renovations to the Imaging Services Department will be required to accommodate the new equipment but will not result in the offering of any new institutional health service.

The costs associated with the project are as follows:

Renovations to Imaging Department:	\$713,113
Siemens Somatom CT Scanner:	\$1,247,119
Total Capital Costs:	\$1,960,232

Because the project does not constitute a new institutional health service as defined in §131E-176(16)b, and does not exceed the cost threshold for major medical equipment as defined in §131E-176(14o), WakeMed believes this project is not subject to certificate of need review and is requesting that the Agency confirm that WakeMed may proceed without first obtaining a CON.
