Dear Dr. Greene and Dr. Craddock,


I have practice Nephrology in the Nash, Wilson, Edgecombe, Pitt and Greene County areas for more than 30 years. I wish to express my support of the petition submitted by Carolina Vascular Care, PLLC for an adjusted need determination in the 2023 State Medical Facilities Plan for a one operating room specialty ambulatory surgical center restricted to outpatient vascular access procedures in Nash County. I understand that the facility will serve End Stage Kidney Disease patients to ensure continued, convenient vascular access care for these patients in an outpatient setting.

Presently, this service does not exist in Nash or adjacent Wilson, Halifax, Edgecombe, or Northampton Counties. Our dialysis patients must travel to the outpatient facilities in the Raleigh area or the Greenville area to get routine and emergency maintenance vascular access procedures. The centers are quite far, inconvenient and moreover have become too busy to take care of our dialysis patients. Resultantly, our dialysis patients either do not get timely vascular access care or end up in the hospital. As a local nephrologist, I have knowledge of the growth and aging of our dialysis patients in these rural counties. There is a critical need for a local outpatient vascular access surgery center in our area to provide cost-effective, convenient, and high quality outpatient vascular access care. The proposed Carolina Vascular Care facility would benefit my patients by insuring on-going access to vascular access care for this vulnerable patient

population. The proposed Rocky Mount location would be central and geographically accessible to residents from throughout Nash, Edgecombe, Wilson, Halifax and Northampton counties, and will provide equitable and timely access to ambulatory surgery patients.

Carolina Vascular Care and its physician are experienced providers, with a history of providing high-quality healthcare services, which are also available to medically underserved residents. I believe this project is in the interest of Nash and surrounding county residents. I strongly support Carolina Vascular Care's petition for a special need for a specialty ambulatory surgery center providing vascular access care in Nash County. Carolina Vascular Care has my support in this important community endeavor and I hope you will approve the special need.
